**FedSelect™ is a dynamic and forward leaning software tool** that easily guides proposal evaluators through electronic evaluation forms to document proposal strengths, weaknesses, clarifications, and deficiencies, and enables evaluators to clearly document sound, justified ratings and rationales.

**The FedSelect™ design is founded in CACI's knowledge of the government acquisition process** and the company's expertise in software development making this tool intuitive, easy to learn and usable to a vast majority of source selections and evaluations.

**FedSelect™ is a low cost tool that standardizes the evaluation process** and provides a clear and consistent structure to a wide-range of competitive procurements. This standardization is achieved through the use of four mission-specific modules: Administration, Evaluation, Reports and Consensus. The four modules serve as a roadmap to guide users through the source selection process by documenting findings and constructing rating and rationale summaries that lead to a final award recommendation.

FedSelect™ eases the administrative burdens associated with an evaluation by providing:

- An organized evaluation
- Quality assessments
- A complete record to successfully defend against a protest
- Customizable evaluation tool for use on any type of source selection
- Complete, traceable and transparent interim and final documentation
- Contracting Officer access to monitor evaluator's progress in real-time
- Substantial cost savings and time reduction over traditional paper-based source selection procedures

**FedSelect™ is an easy to learn software tool** with a straightforward user interface eliminating cumbersome training, thus enabling evaluators to efficiently complete evaluations.

FedSelect™ it does not need to be re-entered in the future. Only solicitation specific information needs updating.

## The New FedSelect™ v.4.0

- The graphical user interface (GUI) has been redesigned for a more intuitive, user friendly and consistent appearance.
- Allows evaluators to easily view Proposal Documents, Request for Proposal (RFP) and any other source selection documents within FedSelect™.
- Allows evaluators to assign a separate rating to subfactors.
- Allows the evaluator to associate strength or weakness comments to paragraphs in the Statement of Objectives (SOO), Statement of Work (SOW) or other supporting documents offering greater sort/filtering capability while evaluating.
- Contracting Officers have summary data of all evaluator's proposal evaluation progress and current users logged into the system.
- Allows Contract Officers and Leaders to evaluate proposals under their own login, in addition to maintaining their management roles.
- Allows users to generate FedSelect™ reports on-screen and export them to Microsoft Word or Excel. Users can also generate ad hoc reports so that specific information can be displayed in a combination of formats.

## Source Selection Facility
