The small, discreet Servator device (just 27 cubic centimeters in volume – slightly larger than a nine-volt battery) can be armed and disarmed by the Servator application from any mobile device. Using cloud-based machine learning analytics, Servator provides unprecedented visibility into cargo in transit by recording, analyzing, and encrypting detailed sensor and tracking information. Servator can assuage concerns such as insurance liability, chain of custody, package content security, and improper handling. Because of its small size and low power demand, Servator also holds great promise for tracking autonomous vehicle-delivered cargo, where tampering, package impacts, temperature, and humidity information is all vital.



How Servator Secures Your Supply Chain

The Servator solution consists of multi-sensor data collection devices, a mobile app, cloud machine learning, and secure data storage. Servator uses advanced software analytics to fuse sensor data and apply heuristic machine-learning algorithms to protect all types of cargo, such as cases, pallets, and trailers. When tampering is detected, Servator collects pictures and records audio for evidence collection. With advanced algorithms fusing numerous sensors, Servator minimizes false alarms, generating improved tamper protection across a range of scenarios.

The mobile app allows users to take pictures of cargo, scan bar codes, and enter serial numbers and other data for shipment preparation. This information goes to the Servator secure cloud and is available to the cargo recipient to ensure contents are not altered in transit. Tracking information is monitored via cloud as well to correlate where detected activity occurs. All detected events and data are then accurately logged and optionally stored in the Servator secure cloud.

The Servator device's extremely low power design allows long-duration use between recharging. Servator can serve as both an "end to end solution" and can be readily integrated into other supply chain management systems.
