Government-Wide Acquisition Contract (GWAC)



The General Services Administration (GSA) Alliant 2 government-wide acquisition contract (GWAC) is a Best-in-Class (BIC) contract for information technology (IT) services, as designated by the Office of Management and Budget (OMB). Alliant 2 is a multiple-award, indefinite-delivery, indefinite-quantity (IDIQ) GWAC offering comprehensive and flexible IT solutions to U.S. Government agencies around the globe. Alliant 2 can address nearly any customer IT requirement – anywhere.

The scope of Alliant 2 is aligned with the Federal Enterprise Architecture (FEA) and the Department of Defense Information Enterprise Architecture (DoD IEA), which encompasses all components of an integrated IT solution, including new technologies that may emerge during the duration of the contract. Alliant 2 provides IT solutions through a broad range of services which may include the integration of various technologies critical to the services being acquired, and incorporates leading edge technologies such as artificial intelligence (AI), robotic process automation (RPA), autonomic computing, cloud computing, big data, biometrics, and cybersecurity.

The Alliant 2 ordering guide provides simple, straightforward steps for using the contract along with world-class support from the program office. Both virtual and on-site training for proper contract use is offered at no cost, along with a self-paced, online course at the Defense Acquisition University (DAU).

The Alliant 2 GSA contract is a unique contract tool to procure IT services, designed to be competitive with GWACs and MACs. Alliant 2 is competitively awarded, along with contract orders. Delivery orders (DOs) and task orders (TOs) are also competitively awarded, with requests for quotes (RFQs) sent to all awardees.

Alliant 2 meets DoD Section 803 acquisition guidelines and rules for fair opportunity, and OMB's BIC designation means it is a preferred government-wide contract solution. The contract does not have functional areas or task area segments for customers to manage, and contractors are qualified and vetted by GSA to perform the full range of IT services needed by the U.S. Government and DoD. Any subcontractors are selected at the DO/TO level, based on requirements.

Competitive Rates, Long-Term Reliability

GSA has determined that Alliant 2 rates are fair and reasonable, and can be adjusted to accommodate requirements such as high-level clearances and special skills. Alliant 2 does not require payment of a contract access fee (CAF) of .75 percent, payable to GSA.

Alliant 2 has a five-year base and five-year option, and task orders awarded during the term of the contract can extend five years beyond the term. As a follow-on to the Alliant GWAC, Alliant 2 customers have a built-in pipeline. As a long-term contract, Alliant 2 reduces the potential for contract gaps and cost back on administration related to recurring requests for proposals (RFPs) and RFQs.
